How you can help

Making a difference in the life of a young girl is a gift of immeasurable consequence. Members of the National T.T.T. Society Founders Circle continue to make a difference by ensuring the future of the Society. You can plan for the future by including T.T.T. in your estate planning so that young girls enjoy summer camp in the years to come.

Founders Circle

All donors who include T.T.T. in their financial planning with a planned gift of at least \$2,500.00, either in a will, trust, onetime, or ongoing gift, will be recognized with inclusion in Founders Circle.

Founders Circle members can be recognized in *Tidings* and at National Conventions. Golden Founders Circle pins are given to Founders Circle members as a recognition of their gift.

Kinds of gifts

Forms of gifts T.T.T. accepts:

- *Cash, stocks or bonds* from a will or trust
- *A life insurance policy* with T.T.T. named as the beneficiary.
- *Distribution from a retirement fund* (IRA, 401k, 403b, 457, pension plan or annuity, etc.) with T.T.T. named as a beneficiary.

Planned gifts are assumed to be part of the donor's financial planning. The gifts often result in tax savings. Please discuss your plans with your family, financial planner, attorney, or tax advisor.

Designate your gift

Donors may designate the T.T.T. Fund that will receive the gift. Bequests may be given to the

- **Project Fund** - to pay camp expenses and Society operations.
- **Endowment Fund** - a long-term investment fund that provides interest/principal for our Project.
- **Kay Eng Fund** - assistance for campers with special needs and support of the camping project.

Donors may also designate their gift to multiple Funds by indicating the percentage of the gift assigned to each Fund. Gifts may also be given in honor or memory of someone special.

Any planned gift that is not designated for at least one of the T.T.T. funds, will be distributed by the National Executive Board when the gift is received. All gifts are considered unrestricted so that the monies may be used to meet the needs of the Society.

How to make a planned gift

Once you decide to make a planned gift to T.T.T., please do the following:

- *Complete the T.T.T. Planned Gift Donor Form:* specify your gift, the fund(s) you support, and how you would like to be recognized.
